

**ORDINANCE NO. 2006 - 367**

An ordinance to amend Chapter 62, Article IV, Section 62-77 of the Code of Ordinances, Charter Township of Ypsilanti, to increase sewage disposal service rates.

BE IT ORDERED BY THE CHARTER TOWNSHIP OF YPSILANTI, that:

Section 62-77 of Chapter 62, Article IV of the Code of Ordinances be revised as follows:

For all billings rendered prior to September 1, 2006, existing sewage disposal service rates shall prevail. For all billings rendered from September 1, 2006, to December 31, 2006, charges for sewage disposal services shall be as provided for in Schedule A, for each bimonthly (two-month) period, and for all billings rendered on or after January 1, 2007, charges for sewage disposal services shall be as provided for in Schedule B, for each bimonthly (two-month) period:
